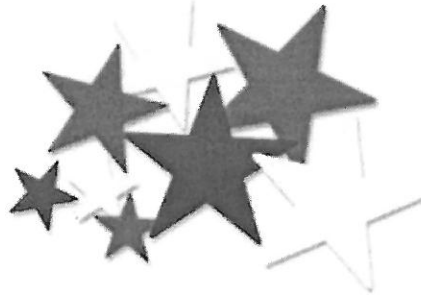

## Child Tax Credit Advance Payments on the way for many Americans.

The American Rescue Plan, signed into law in March, made important changes to the CTC for most taxpayers in 2021. The credit amount increased and is now fully refundable. The credit also includes qualifying children who turn 17 in 2021.

The American Rescue Plan directs the IRS to make advance monthly payments of *half* the estimated annual CTC through monthly payments from July to the end of this year. The credit amounts have also increased based on the qualifying child's age.
